PREAMBLE

WHEREAS, [NAME OF BODY] supports President Donald J. Trump and the America First agenda as a matter of its political judgment and institutional position; and

WHEREAS, [NAME OF BODY] finds that criminal and civil legal processes must never be used selectively to interfere with elections, punish political opposition, or burden citizens because of their political beliefs or associations; and

WHEREAS, it is the position of [NAME OF BODY] that legal proceedings directed against President Trump, members of his family, and his supporters have included lawfare, political prosecution, and weaponized process amounting to election interference and an assault on republican government; and

WHEREAS, every criminal defendant is entitled to due process of law, a fair and speedy trial, and protection against cruel and unusual punishment under the United States Constitution; and

WHEREAS, [NAME OF BODY] finds that complete disclosure of government records concerning January 6, 2021, subject only to lawful and narrowly tailored protections, is necessary for public accountability and informed congressional oversight; and

WHEREAS, Congress possesses authority to investigate the conduct of federal agencies, informants, and personnel and to determine whether entrapment or other misconduct occurred;

NOW, THEREFORE, BE IT RESOLVED, that [NAME OF BODY], after due consideration, adopts the following provisions as its formal position and call to action:

OPERATIVE PROVISIONS

SECTION 1. [NAME OF BODY] gives its complete and enthusiastic support to President Donald J. Trump and the America First agenda and strongly condemns what [NAME OF BODY] regards as lawfare, political prosecutions, and weaponized legal proceedings against President Trump, his family, and his supporters as blatant election interference and an assault on the republic;

SECTION 2. [NAME OF BODY] demands the immediate release of any January 6 defendant whom [NAME OF BODY] finds is being held as a political prisoner in violation of constitutional rights, or, where proceedings remain pending, the guarantee of a fair and speedy trial, due process, and protection against cruel and unusual punishment;

OPERATIVE PROVISIONS — CONTINUED

SECTION 3. [NAME OF BODY] demands the immediate and full public release of all Capitol surveillance footage from January 6, 2021, and all investigative files, subject only to lawful and narrowly tailored protections for personal privacy or operational security, together with a full congressional investigation into the role of Federal Bureau of Investigation informants, agents provocateurs, and any entrapment operations conducted against American citizens.

FURTHER RESOLVED

BE IT FURTHER RESOLVED, that the officers and authorized representatives of [NAME OF BODY] shall communicate these positions, advocate for the requested disclosures and investigation, and monitor official responses and material developments concerning the matters addressed herein;

BE IT FURTHER RESOLVED, that copies of this Resolution shall be transmitted to President Donald J. Trump, the Attorney General of the United States, the Director of the Federal Bureau of Investigation, the Director of the Federal Bureau of Prisons, the Speaker and minority leader of the United States House of Representatives, the majority and minority leaders of the United States Senate, the chairs and ranking members of the congressional judiciary and oversight committees, and New York's congressional delegation;

BE IT FURTHER RESOLVED, that this Resolution shall be made publicly available and may be circulated as a citizen petition, with [NAME OF BODY] authorized to collect and transmit signatures in support of the positions and demands stated herein in accordance with applicable law;

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption by [NAME OF BODY] and shall remain the stated position of [NAME OF BODY] unless amended or rescinded by subsequent action;
