PREAMBLE

WHEREAS, public officers and federal agencies exercise authority in trust for the American people and must remain accountable to constitutional government, elected leadership, and the rule of law; and

WHEREAS, [NAME OF BODY] finds that reported and documented failures in protective operations require transparent investigation, leadership accountability, and referral for prosecution when supported by evidence; and

WHEREAS, it is the position of [NAME OF BODY] that entrenched and unaccountable federal personnel in policy-making roles can frustrate lawful executive direction and that personnel systems should permit the removal of officials who misuse public authority for partisan or ideological purposes; and

WHEREAS, [NAME OF BODY] finds that allegations of political weaponization within intelligence, law-enforcement, and regulatory bodies, including the Federal Bureau of Investigation, warrant comprehensive institutional reform and effective congressional oversight; and

WHEREAS, [NAME OF BODY] holds that surveillance under the Foreign Intelligence Surveillance Act must include meaningful safeguards against abuse involving United States citizens; and

WHEREAS, [NAME OF BODY] finds that the public interest favors declassification and disclosure of historically significant and public-health-related government records and investigation of alleged official concealment, manipulation of data, or censorship, subject to lawful protections for genuinely sensitive information;

NOW, THEREFORE, BE IT RESOLVED, that [NAME OF BODY], after due consideration, adopts the following provisions as its formal position and call to action:

OPERATIVE PROVISIONS

SECTION 1. [NAME OF BODY] demands full accountability and a complete leadership overhaul of the United States Secret Service for documented protection failures, together with congressional investigation and criminal referrals wherever warranted by the evidence;

SECTION 2. [NAME OF BODY] demands the reinstatement and aggressive use of Schedule F, or a lawful successor classification, to reclassify and remove unaccountable federal bureaucrats in policy-making positions, and the removal of officials who are disloyal to their constitutional duties or who politically weaponize intelligence, law-enforcement, or regulatory authority;

OPERATIVE PROVISIONS — CONTINUED

SECTION 3. [NAME OF BODY] demands comprehensive reform of the Federal Bureau of Investigation to eliminate political weaponization, ideological bias, and the targeting of American citizens for their political beliefs, as well as meaningful reform of the Foreign Intelligence Surveillance Act process to prevent surveillance abuse against United States citizens;

SECTION 4. [NAME OF BODY] demands, subject only to lawful and narrowly tailored protections for genuine national-security or personal-privacy interests, the full declassification and public release of all remaining records concerning the assassination of President John F. Kennedy, all intelligence concerning the origins of COVID-19, and all other suppressed government records; and further demands a full investigation—with criminal referrals—of any officials determined to be responsible for COVID-19-origins cover-ups, data manipulation, or censorship of dissenting scientists.

FURTHER RESOLVED

BE IT FURTHER RESOLVED, that the officers and authorized representatives of [NAME OF BODY] shall advocate for the foregoing accountability, personnel, institutional, surveillance, disclosure, and investigative measures and shall track and report material official action on those demands;

BE IT FURTHER RESOLVED, that copies of this Resolution shall be transmitted to the President of the United States, the Attorney General of the United States, the Director of National Intelligence, the Director of the Federal Bureau of Investigation, the Director of the United States Secret Service, the Archivist of the United States, the majority and minority leaders of both houses of Congress, the chairs and ranking members of the appropriate congressional judiciary, intelligence, oversight, and homeland-security committees, and New York's congressional delegation;

BE IT FURTHER RESOLVED, that this Resolution shall be made publicly available and may be circulated as a citizen petition, with [NAME OF BODY] authorized to collect and transmit signatures supporting the reforms and disclosures demanded herein in accordance with applicable law;

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption by [NAME OF BODY] and shall remain the stated position of [NAME OF BODY] unless amended or rescinded by subsequent action;

- ★ Reinstate and aggressively use Schedule F and remove disloyal or politically weaponized officials from intelligence, law-enforcement, and regulatory bodies.
- ★ Declassify and release remaining JFK records, COVID-19-origins intelligence, and other suppressed records.
