PREAMBLE

WHEREAS, [NAME OF BODY] affirms as its position that biological sex is binary, immutable, and determined at conception, consistent with its understanding of science and natural law; and

WHEREAS, [NAME OF BODY] finds that sex-based athletic categories are necessary to preserve fair opportunities for women and girls at scholastic, collegiate, and professional levels; and

WHEREAS, [NAME OF BODY] finds that women and girls have legitimate interests in privacy, safety, dignity, and equal access within single-sex facilities and services; and

WHEREAS, [NAME OF BODY] therefore supports clear state and federal protections based upon biological sex in female athletics and designated women's spaces; and

WHEREAS, [NAME OF BODY] believes public policy should use clear and consistent sex-based definitions when governing athletics, privacy-sensitive facilities, correctional placements, and services reserved for women; and

WHEREAS, the people retain the right to petition public officials for laws and policies that preserve female athletic categories and designated single-sex spaces;

NOW, THEREFORE, BE IT RESOLVED, that [NAME OF BODY], after due consideration, adopts the following provisions as its formal position and call to action:

OPERATIVE PROVISIONS

SECTION 1. [NAME OF BODY] affirms that biological sex is binary, immutable, and determined at conception, as recognized by the body's understanding of science and natural law;

SECTION 2. [NAME OF BODY] demands state and federal legislation prohibiting biological males from competing in female sports at every level, including scholastic, collegiate, and professional athletics;

OPERATIVE PROVISIONS — CONTINUED

SECTION 3. [NAME OF BODY] demands protection of single-sex spaces—including women's prisons, domestic-violence shelters, locker rooms, and restrooms—from access by biological males, regardless of claimed gender identity.

FURTHER RESOLVED

BE IT FURTHER RESOLVED, that the officers and authorized representatives of [NAME OF BODY] shall advocate for legislation and administrative action implementing the foregoing policies and shall report to the body on material action concerning them;

BE IT FURTHER RESOLVED, that certified copies of this Resolution shall be transmitted to the Governor of New York, the New York State Legislature, relevant state education and corrections authorities, the President of the United States, and members of Congress, as applicable;

BE IT FURTHER RESOLVED, that this Resolution shall be made publicly available as a citizen petition, and that [NAME OF BODY] may collect supporting signatures at its events, community gatherings, houses of worship, and public forums;

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption by [NAME OF BODY] and shall constitute the official position of the body unless amended or rescinded by subsequent action;
