PREAMBLE

WHEREAS, [NAME OF BODY] affirms as its position that innocent human life is sacred from conception and is entitled to the strongest protection permitted by law; and

WHEREAS, [NAME OF BODY] supports legal measures intended to protect unborn children, including heartbeat legislation and earlier gestational limits; and

WHEREAS, [NAME OF BODY] finds that taxpayers should not be compelled to fund organizations that perform or promote elective abortions; and

WHEREAS, [NAME OF BODY] recognizes the important role of pregnancy resource centers, adoption services, and ministries in providing compassionate alternatives and practical support to women, children, and families; and

WHEREAS, decisions concerning public funding should reflect accountability to taxpayers and the body's stated commitment to protecting innocent human life; and

WHEREAS, the people retain the right to petition public officials and to organize community support for policies and services that protect women, children, and families;

NOW, THEREFORE, BE IT RESOLVED, that [NAME OF BODY], after due consideration, adopts the following provisions as its formal position and call to action:

OPERATIVE PROVISIONS

SECTION 1. [NAME OF BODY] affirms the sanctity of innocent human life from conception and supports the strongest possible pro-life protections under law, including heartbeat legislation and earlier gestational limits;

SECTION 2. [NAME OF BODY] demands, to the fullest extent permitted by law, the complete defunding at the federal, state, and local levels of Planned Parenthood and any organization that performs or promotes elective abortions using taxpayer funds;

OPERATIVE PROVISIONS — CONTINUED

SECTION 3. [NAME OF BODY] calls upon the community to support local pregnancy resource centers, adoption services, and ministries that provide compassionate alternatives to abortion.

FURTHER RESOLVED

BE IT FURTHER RESOLVED, that the officers and authorized representatives of [NAME OF BODY] shall advocate for the foregoing legal and funding policies and shall encourage community awareness of local pregnancy resources, adoption services, and supporting ministries;

BE IT FURTHER RESOLVED, that certified copies of this Resolution shall be transmitted to relevant local governing officials, the Governor of New York, members of the New York State Legislature, the President of the United States, and members of Congress, as applicable;

BE IT FURTHER RESOLVED, that this Resolution shall be made publicly available as a citizen petition, and that [NAME OF BODY] may collect supporting signatures at its events, community gatherings, houses of worship, and public forums;

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption by [NAME OF BODY] and shall constitute the official position of the body unless amended or rescinded by subsequent action;
